Academic:

Osprey Wilds Academic Performance feedback. The board members reviewed
the level of performance with the contract goals. Specific questions were asked

E. ACTION ITEMS

- 1. 990 form: Dave Smith moved to approve the 990 as presented. The motion was seconded by Brady Jones and passed unanimously.
- 2. Employee Benefits: Quotes for medical, dental and fringe benefits were discussed. Medica did not increase the overall rate and are providing a \$5000 Wellness credit for the school to use. Dental benefits went up 8% with Delta Dental, but remain the same rate if AFSA moves to MetLife Dental. All other benefits stay at current rates for another year. Gerard moved to accept the renewals for Medica and fringe benefits with Mutual of Omaha as they were with a change to Met Life for dental insurance. Julie seconded the motion and it passed unanimously.
- 3.Katie Crowley moved to take from the table the motion to keep the admin team the same for the FY 24 school year. Gerard Cramer seconded the motion to take the original motion from the table and it was passed unanimously. Board members discussed the original motion, requesting information on jobs posted, financial ramifications and job duties. The motion failed with Katie Crowley abstaining. All other members present voted no.

Brady Jones moved to adopt the new organizational chart with the associated administrative changes. Gerard seconded the motion. Board members asked if the positions that were not being cut needed to be posted. It was explained that in industry if less than 50% of job duties change, it is not considered a new position. The motion passed with Katie Crowley abstaining and all other board members present voting yes. 4.Positions with board oversight: Kate reviewed the process of evaluations for Liz Burkwald and Bill Lloyd. Their performance reviews were done by Erik Bruner-Wiltse and provided to the Executive committee for review. Brady Jones moved to offer contracts for the FY 24 school year to Liz Burkwald and Bill Lloyd. Dave Smith seconded the motion which passed unanimously.
